**Passes will only be processed in person, valid photo ID required!**

A "Rec Pass" is **required** for entrance to the Association pools and must be available for display at the tennis courts during play. An individual's Rec Pass may be suspended for violation of the published recreation rules. Rec Passes for all residents in a home may be suspended for delinquent assessments or unresolved architectural violations. Passes will not be issued to anyone from a unit in such status. Applicants with an unusual number of "residents" may be asked for proof of the persons listed on the application: applicant who cannot or do not provide such evidence will be denied passes. Due to capacity limits of the pools, passes may be issued to owners or their tenants, but not both.
